2. Annual Financial Report

The report was presented by Angus Cotton

Bamba paid a total of **\$6,667.26** in expenses during the financial year, with notable (>=\$200) expenses as follows:

- \$4,508.00 for Valley Landscapes to complete the Connect Four trail.
- \$402.50 for digger hire which allowed work on Electric Avenue by Paul Lissette.
- \$259.99 for Trail Fund Hilti Hoes.
- \$375.00 Cycling NZ and MTBNZ affiliation fees.
- \$251.03 for Hamburger fundraiser supplies.

Bamba earnt a total of **\$4,236.81** in income and interested during the financial year, with notable (>=\$100) items as follows:

- \$1500.00 grant from Trail Fund
- \$535.00 from PNP Belmont Round races.
- \$250.00 donation from Maxam Corporation

3. Presidents Report 2016 - 17.

Paul Scoble's Report:

I recently took some time whilst completing our promo presentation for an open day to look back over the past 7 years since I joined BAMBA in late 2010 and I thought it would be prudent to remind us all of what has occurred and what BAMBA has achieved over those years gone. I was pleasantly reminded, whilst searching through the photo and video files, of what we have accomplished as a small group since the logging commenced in late 2012 when we all lost 5 great trails in the Danzig Pine block area. The trail names: Last Sun, The Slide, Choppers, Big Weta and of course Danzig are all but distant memories now. Sweeping through those pines is a pastime long gone, however as we are required to adapt and move with the changes it is great to look on what has been achieved since those trails were lost.

We started with "Bull-a-Varde" in 2012 and then officially opened "Bull Run" in Dec 2013. Following on from Bull Run we completed our grade 4 downhill trail from the top of Old Coach Road to Stratton Street and bingo "Borderline" was born and opened in Nov 2014. A gas line trail from View point Pylon was then cleared in 2015 ready for a PNP race and we named that "Naked Flame".

Late 2015 saw the official opening of the GWRC funded 4 Degrees trail built by Paul O'Hagan and his boys from Valley Landscapes. This 2 way trail gave us all the long awaited uphill replacement for Danzig. This trail is still used as the primary way up from the bottom of Stratton Street to Old Coach Road.

BAMBA created Weta in 2015 and tweaked it again in 2016, then moved forward with "Connect Four" being completed in May 2016 and then of course our greatest and newest downhill only trail "Electric Avenue" was done and dusted and ready to rock in March of this year. And now we wait with baited breath for GWRC to start and complete the long awaited uphill from Hill road, plus Cowboys new grade 5 downhill, – These will be awesome for the park too just like the others now constructed.

Looking back, it sure is pleasing to see how far we have come since 2012.

Our relationship with GWRC is stronger than ever.

We have in place a good MoU and we have been able to work well with both the Park Ranger (Jeremy) and the Principle Ranger (Wayne Boness).

We are also lucky enough to have on board people such as Paul O'Hagan and his staff plus others like Paul Lissette from "Dirt Mechanics who freely give up their time and expertise to assist us when they can.

Naturally I must also make mention of the two key organisations who have also helped the club over past and also in recent times. Both Trail Fund NZ and Ground Effect have helped us immensely and without their invaluable funding things sure would have been a lot tougher for us and the riders who benefit too.

So a huge high-five and cheers to all the above for your massive support!

This year and the last have been busy for me as President however I can happily say that I have enjoyed most of the challenges I have had to face. In the past as Secretary or in the role as President it has been a very rewarding time. Yes, there is no doubt that at times it has been taxing but I guess if it was always easy then perhaps it would have become boring. This year however I have decided to take a good step back and remove myself from the committee altogether. For me I feel it is time for a good break away from all the arranging and other related tasks I have had to carry out.

Now is as good a time as any to allow others to step up and give what they have to offer. I will of course still be around and more than happy to show up for a dig here and there, however my plan is to get out and enjoy those trails a lot more than I have been able to do.

I would therefore like to take this opportunity to personally thank a few people before I stand down!

To Wayne Boness (GWRC Principal Ranger) – It is great that you and I have worked closely together when required and that we have always had good clear communications with each other. It is appreciated that BAMBA has had that important clear and transparent relationship with you and GWRC as a whole. What's more I have appreciated your help and assistance over the years.
